Skaters must be ready to test up to sixty (60) minutes before their scheduled time.

Deadlines: Applications must be date stamped or postmarked twenty-one (21) days from the requested test date. Gold Test applications must be dated and fees received 45 days prior to a test session. No refund or credit is given if the skater or the coach of the skater cancels a test less than 14 days before the test session for all tests except Gold Tests, which require 30 days advance notice to cancel with credit. Only exception is an illness with a doctor's statement.

Late Applications and On-Demand Test Sessions: ALL applications dated beyond the deadline and ALL On-Demand Test Sessions will be assessed a late fee of 1-1/2 times the fee for that test.

Individual Members of the USFSA and Skaters From Other Clubs: Test fees are for full skating members of the Nashville FSC, Memphis FSC, Knoxville FSC, Huntsville FSC, and Birmingham FSC. Skaters from other USFSA clubs pay 1-1/2 times the listed NFSC member fees. Individual Members of the USFSA pay three (3) times the listed NFSC member fees. If an Individual Member is required to retry a test, they can retake the test at 1-1/2 times the listed fee at the next session only. Prospective test candidates must be members in good standing with the respective clubs to be eligible to test. A letter of good standing or a letter of Authorization to Test must be attached to this form if the skater is not a member of the Nashville FSC.

Payment and Fees: Full payment must accompany all test applications. Checks returned for insufficient funds will be assessed a \$25.00 fee. In the event an error is made in payment, the applicant will be notified, and in every case, fully payment must be received before the skater is allowed to test.

Note: Skater's applying for multiple tests, where the second is contingent upon the first, and who do not pass the first, thus not qualifying for the second test, forfeit the fees for both tests.
